

Paper Production

Project Description

Feasibility studies are done for two projects:

- Establishment of a new State of art paper mill plant with two production lines to produce :
 - Test liner and fluting at a lower production cost and higher quality, 500 tons / day.
 - Coated duplex with a production capacity of 220 tons / day as well as luxury duplex for pharmaceutical packages at high quality and lower cost of the production.
- Establishment of an integrated line for the production of virgin pulp with a production capacity of 250 tons / day of dried bleached / unbleached pulp boards to be used as a raw material for hygiene paper production factories, as well as high quality virgin kraft used in food and pharmaceutical packaging.



Cotton Spinning & Weaving Complexes Cotton Dying and Finishing Cotton Finished Products Inputs Sourcing

Project Description

- More than 23 Billion EGP are being invested to upgrade seven cotton spinning and weaving companies, and one polyester company.
- The upgrade covers construction, machinery, infrastructure, human capacity building, and enterprise resource planning.
- The reform intends to serve the needs of investors in the area of ready made garments, both locally and globally, through a specialized entity established for marketing, sales and supply chain management

Target Form of Cooperation

- A know how experienced entity is welcomed for O&M Contract for one of the three main complexes, covering the spinning, weaving, and dying and finishing stages of the supply chain.
- For the Dying and finishing stage, the know how experienced entity, may be offered an equity stake in an SPV managing the function in all three complexes.
- Local and international players in the area of ready made garments are invited to cooperate with the new supply chain company, for their input needs.
- Contractual farming for short staple cotton.



B2B Trading & Logistics

Project Description

- Nasr Export Import Company (now rebranded as Gosoor), is now applying a new business model based on intermediation and opening new markets for exports & SMEs.
- New branch network has been developed to reach 40 markets through 14 hubs, managed by local professional sales teams, working on commission basis.
- E-Catalogue for Egyptian exports and their imported inputs has been developed (www.gosoor.com.eg)
- Full set of logistical services are offered to exporters through partnerships with specialized service providers in each area. In addition to partnership with financial institutions to avail banking and insurance services to our clients.

Agriculture & Animal Farming & Processing

Project Description

- Total area of 30,000 acres has been reclaimed in the Toshka with advanced irrigation systems (axial irrigation - drip irrigation - spray irrigation)
- A state of the art automated slaughter house has been recently commission.
- Making the local available for agricultural projects, animal farming, and food (as well as other products) processing from both agricultural and animal sources.
